# Introduction to Higher Education

Higher Education from Cambridge University Press is the home for our textbooks, shaped by extensive feedback from librarians, students and instructors. An innovative, fully integrated digital website, it provides users with easy, affordable access to textbooks, together with all available supplementary teaching and learning materials. It is built on the same technology as Cambridge Core with the aim of making searching across the full breadth of our publications easier than ever before.

Users can bookmark, annotate and highlight text, and navigate through personalized copies in a way that makes sense to them. There is also cut and paste (20% by word count) and print (20% by page count) functionality per e-textbook for each user. Content will automatically resize to display on mobile devices and can be read both on and offline using our e-reader app. Instructors also have access to a streamlined process for requesting examination copies.

Access is provided through an annual lease, either to individual titles or collections that will grow as new books are published. Leases allow for an unlimited number of concurrent users.

During the site's first year, the number of textbooks grew from a few hundred to nearly 1,000. New, born-digital textbooks were and continue to be added as they're published. In addition, some flat-HTML textbooks, and other full-functionality textbooks formerly withdrawn from sale, were moved onto the site.

#### Why access e-textbooks on Higher Education?

Cambridge University Press has introduced a new set of strategies to support the changing teaching and learning needs as higher education institutions prepare for a more digitally driven future.

The structure and function of the Higher Education website prioritises easy and continuous accessibility for all users, especially people with disabilities. Using the Web Content Accessibility Guidelines (WCAG) 2.1, which explain how to make web content more accessible for people with disabilities; an annual accessibility audit; and accreditation from the Digital Accessibility Centre, the site ensures all members of the higher education community share the same experience in reading and accessing academic content, so that libraries are better equipped to support all patrons.

Digitalisation of education has sharpened all our senses by offering a variety of content formats to choose from, including video and audio lessons, interactive texts and infographics, and many more.

Recent events have highlighted how important it is for students to access learning materials remotely, without always having to go through their institutional websites. A key development of this site is that students are now able to access books offline while they are travelling or at home by logging on with a laptop, mobile phone or tablet.

Valuable usage data, including COUNTER5 reporting, is available to librarians via their administrator accounts on Cambridge Core.
